- 5. Setup should be minimal and should take no more than 5 minutes between acts, contestants must provide all equipment and setup needed for performance
- 6. All contestants must be at the pavilion at 5:30 PM on September 30, 2022 for registration.
- 7. No fire or weapons are permitted.
- 8. Contestants subject to disqualification as needed.
- 9. Contestants/employees only back stage.
- 10. Prior to performance no contestant/Judge interactions
- 11. No alcohol/drugs allowed on festival grounds.
- 12. Participants may be requested to sign a release of liability before performance.
